102/24	Public Opportunity A resident raised the concern of racing vehicles along Church Lane. It was agreed that the Clerk will raise the issue of noise and anti-social behaviour with Inspector Ross Wickings CW114, Arun Neighbourhood Policing Team (NPT) & ADC Environmental Health.

103/24	<p>Minutes – Minutes of the Full Council Meeting held on the 24th September 2024 were confirmed and signed by the Chairman as a true record.</p>
104/24	<p>Actions update from the last meeting – There was nothing to mention.</p>
105/24	<p>Comments from County and District Councillors County Councillor Jacky Pendleton advised the following: In relation to the Footpath closure of FP175, the Community Liaison Group are meeting with the Vistry (Ford Landings developer) on Thursday 21st November where this matter will be discussed. Councillors Tim Hibbert and David Miranda will also attend the meeting. It was noted that as this is a temporary closure, WSCC do not have legal right to require the developer to provide an alternative footpath. Whilst the decision for the six-month road closure at Bilsham Road was challenged, unfortunately due to unstable verges, the gas pipes are being positioned into the road hence the need for the long closure. Reference to Foreman Homes, there has been no response from the WSCC Archeologist. A259 proposal is currently being reviewed by Department of Transport. District Councillor Amanda Worne: Councillor Amanda Worne provided a report in her absence that was read by Councillor Colin Humphris. The major concerns of residents currently are the closures of the well-used footpaths linking Clymping, Yapton and Ford safely without having to use the roads. Although footpaths are not an ADC matter Councillor Amanda Worne has been quite involved with talking to a representative for the Landings development about our concerns, and with all the combined pressure from Councillors and residents there is now a meeting on Thursday 21st November to discuss these closures. Councillor Amanda Worne visited the Norden Care Home and met with the Manager who does seem very eager to build firm and friendly links with the local community. The issue with the lighting was discussed and whilst there, the groundsman changed the timer so the lights will go off at 9pm. They are also more than happy to chat to residents about any other issues they may have in a hope to rectify them, including the fence facing Climping Street. There is a new proper ADC sign in place for Longwood Close.</p>

108/24	<p>Transport Working Group meeting held 8th November 1. Footpath closure of FP175 – The Community Liaison Group are meeting with the Vistry (Ford Landings developer) on Thursday 21st November where this matter will be discussed. 2. CIL Application – Council noted that there has been no response following the application made in May to ADC for CIL funding for the HGL pavement. 3. Community Highways Scheme Application – Council noted that the CHS application for Pedestrian Crossing Church Lane has been refused. 4. Future Transport Projects - Council agreed that Clymping Parish Council focuses on more limited but valuable projects. 5. Traffic Regulation Order HGL – The 20 mph Traffic Regulation Order application will be pursued. County Councillor Jacky Pendleton confirmed her support for the application.</p>

	<p>6. MP and the Cabinet Member for Highways – Council agreed to request a meeting with the MP and the WSCC Cabinet Member for Highways.</p> <p>7. A259 Review – County Councillor Jacky Pendleton has a meeting with the WSCC Highways Cabinet Member scheduled for December. It was noted that the Government has asked for a review of all current projects.</p>
109/23	<p>Environment Working Group (EWG) Meeting held 7th November</p> <p>1. HGL Pond – A quotation to complete the desilting work will be obtained for Council consideration at a future Full Council Meeting.</p> <p>2. Fire at Grevatt’s Lane – It was noted that an acknowledgement response to the CPC letters have been received from WSCC & the Environment Agency. It was agreed that CPC will continue to press for answers and request to see the review when it is available.</p> <p>3. Litter Pick Church Lane and the purchase of Safety Equipment – Council agreed to organise a litter pick in Church Lane. The Clerk will liaise with ADC to obtain appropriate equipment. Councillor Anne Miller can provide limited equipment if necessary for any litter picks.</p> <p>4. Swift Bricks and other nature friendly designs - Council agreed to request the inclusion of swift bricks and other nature friendly designs in all new build or significant extensions in the village when considering planning applications or any future Neighbourhood Plan review.</p> <p>5. HGL Meadow – Council agreed to request a further close cut.</p> <p>6. HGL Pond Signage – Council considered signage for the HGL Green and pond making it clear that these are public/community areas and the responsibility of CPC.</p> <p>7. HGL Pond Fencing – Council considered that the fencing on the pond side of HGL is not replaced as it ages rapidly.</p> <p>Noting the above items, 6 & 7, Council supported both suggestions, however, it was noted that the pond is common land. It was agreed that the Clerk will discuss the suggestions with the Parish Insurance provider.</p> <p>8. Membership of the Working Group – Council approved the membership of the work group for Kay Overton. Kay was an original member of Clymping’s Neighbourhood Plan team and now has time available.</p> <p>9. Community Projects - Council agreed to consider any community projects for proposal to Rampion 2 prior to the decision by the Ministry of State early February 2025.</p>
110/24	<p>Community Working Group –</p> <p>1. Clymping Emergency Plan – Councillor Jane Mules advised that there has been a poor response to the questionnaire delivered to all local businesses. However, the businesses that did respond are now members of the Village Resilience Group. The group are meeting this week. An impact Risk Assessment has been produced and any recommendations from the Village Resilience Group meeting will be reported at the next Full Council Meeting.</p> <p>2. Clymping Village News & Parish Council Facebook page – The next edition of the Clymping Village News will be printed and distributed in the next couple of weeks. The Clymping Parish Council Facebook page is now live, it has experienced a slight glitch. that is being looked at presently.</p>
111/24	<p>Clymping Beach – Residents, and especially those in Climping Street, will be aware of the movement of shingle and its use to reinforce the bunds behind the beach to reduce the threat of overtopping. This was privately funded. Council had received an email request from the landowners for further funding from the Parish Council. Councillors then held an informal meeting when it was noted that the grant awarded for similar work in 2023 was specified as a one-off grant. Councillors also noted that the landowner group had already decided to go ahead with moving the large quantity of shingle to Clymping. At the same time, the Environment Agency notified the Parish Council that it is likely that they will have a smaller budget for shingle movement in 2025.</p>

	In response to both, Council agreed that its primary focus should be to keep the Environment Agency actively engaged in their coastal protection responsibilities and ADC for the safety of the beach. Council will however also consider options for ongoing support for bund work whilst reviewing the Precept for 2025 – 2026. A Precept change in this regard may require community consultation.
